

BELLA VISTA CITY COUNCIL MEETING MINUTES – JUNE 25, 2018 REGULAR MEETING

Meeting called to order at 6:30PM by Mayor Christie

Pledge of Allegiance was recited by all present.

City Clerk Jertson called the roll of Council; Members, Frank Anderson, Jim Wozniak, John Flynn and Linda Lloyd were present. Quorum was achieved.

Citizen Input; Christian Henning of 29 Murphy Drive, spoke about playground equipment and its placement in yards in Bella Vista. He stated that as Bella Vista gets younger, the city needs to be more accommodating to the needs of younger families with respect to placement of playground equipment on challenging lots.

APPROVAL OF MINUTES: May 21, 2018 City Council meeting. No corrections or additions were noted and a motion to approve as presented was made by John Flynn, seconded by Linda Lloyd. Motion was approved by all council members present.

Monthly Financial Report for April has been sent to all council members and was available at the meeting for the public.

A Motion to suspend the rules and read all Ordinances and Resolutions on the agenda by title only was made by John Flynn, second by Jim Wozniak. Motion approved by all four council members.

ORDINANCE 2018- AMENDING SECTION 18-20 CLEARANCE OF UNSIGHTLY OR UNSANITARY CONDITIONS ON REAL PROPERTY OF THE CODE OF ORDINANCES OF THE CITY OF BELLA VISTA TO PERMIT PLACING PLAYGROUND EQUIPMENT OR TRAMPOLINES IN THE FRONT YARD OF A RESIDENCE UNDER CERTAIN CIRCUMSTANCES, AND FOR OTHER PURPOSES. (3rd reading)

Council member Linda Lloyd made a motion to table this item indefinitely. John Flynn seconded that motion. Clerk Jertson called the roll and all four council members supported the motion.

ORDINANCE 2018-13 CREATING A TREE ADVISORY BOARD, DEFINING ITS PURPOSE AND MEMBERSHIP, AND FOR OTHER PURPOSES. (3rd reading)

This Ordinance was read for the 3rd time by Mayor Christie. Council member Frank Anderson made a motion to adopt. It was seconded by Linda Lloyd. Vote was taken and was supported by Linda Lloyd, Frank Anderson and John Flynn. Council member Wozniak voted nay. Mayor Christie chose to vote aye. Ordinance adopted.

R2018-31 RESOLUTION ACCEPTING THE RESIGNATION OF BRIAN BAHR AS COUNCIL MEMBER OF THE CITY OF BELLA VISTA FOR WARD 3, POSITION 2, AND DECLARING A VACANCY.

Motion to approve by John Flynn, seconded by Frank Anderson. All four council members voted aye. Resolution adopted.

R2018-32 RESOLUTION APPOINTING COUNCIL MEMBER JOHN FLYNN TO THE BELLA VISTA ADVERTISING AND PROMOTION COMMISSION TO FILL A VACANCY ON THE COMMISSION DUE TO THE RESIGNATION OF BRIAN BAHR.

A motion was made to approve by Linda Lloyd, second by Frank Anderson. All four council members voted aye. Resolution Adopted.
