**AUTHORIZING THE MAYOR TO RESCHEDULE OR CANCEL WORK SESSIONS AND REGULAR SESSIONS OF THE CITY COUNCIL TO PROTECT THE PUBLIC HEALTH, SAFETY AND WELFARE, AND FOR OTHER PURPOSES**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BELLA VISTA, ARKANSAS:**

**SECTION 1:** Notwithstanding the Rules of the Bella Vista City Council, or any resolution scheduling meetings of the Bella Vista City Council which has heretofore been adopted, the Mayor is hereby authorized to reschedule or cancel any work session or regular session of the Bella Vista City Council should, in the Mayor's opinion, the public health, safety and welfare require it.
