I, the undersigned, do hereby certify that I have read and examined this document and know the same to be true and correct. I certify that the application and the attached drawings constitutes a true description of the location on the site for the Temporary Portable Storage Container. All provisions of laws and ordinances governing this type of work will be complied with whether specified herein or not. I understand inspections by City Inspectors will be made only to determine compliance with construction codes and not to assist the owner or contractor in properly locating the structure. I acknowledge my responsibility to insure, by boundary line survey if necessary, that the location of the structure will conform to setback requirements of the Bella Vista Municipal Code. I understand that granting of a permit does not presume to give authority to violate or cancel the provisions of any state or local law. I understand that if I don't comply with the limitations of the applicable code sections, this permit can be revoked.

By my signature below, I hereby acknowledge and understand the following:

1. Approval.

- a. If the plans are approved, a Temporary Portable Storage Container permit will be issued.
- b. If the plans are disapproved, the reasons will be provided in writing to the primary contact.

2. Time periods.

- a. Not more than 30-days per any 12-month period at a residence not under construction.
- b. Permit for construction must have Container removed within 10 days of final site inspection.
- c. Not more than 30-days when used for receiving or shipping merchandise or goods.
- d. For fireworks stand, time period shall not exceed the lawful period of the stand.

3. Number.

- a. Residential: One (1)
- b. Commercial: Prohibited except when meeting Item 2b or 2c above.
- c. Agricultural and Industrial: No limit.

4. Permitting.

- a. Must be completed prior to placement or Container will have to be removed.
- b. Issued permits must be placed on outside of Container in clearly visible location.
